Federal Tribal Lands	Hiring credits up to \$4k/year/employee
Federal Empowerment Zones	Hiring credits up to \$3k/year/employee
Federal Renewal Communities	Hiring credits up to \$1.5k/year/employee
Alabama	80% general tax credit
Arizona	\$3k/employee hiring credit; lower property tax
California	\$31k/employee hiring credit
Colorado	3% investment credit; hiring credit






